• ETrade dividend earnings are 9.08%, roughly \$72.00/month. The earnings will be paid out yearly, at the end of the year, and be treated as a donation to go towards scholarships.

Old Business:

- **Deferment/Alternate scholarship recipient policy**: Janis Volker and Rachel Westberg have drafted a policy for the board to review and discuss. The rough draft was read and multiple changes were discussed. Janis and Rachel will update the draft to reflect the changes discussed at the meeting, and send out to board members for review and approval via email.
- Reunion Fundraising Kit: Jeff Olson reported that it has been determined that the most valuable thing the CWSF can provide to reunion organizers in our effort to fundraise via reunion guests, is personal contact/support by our board members. Jeff shared a rough draft of a letter that would be sent to reunion organizers which would list contact information for board members willing to be contacted. Board members could provide a short "presentation" upon request.
- **Newspaper Graph:** Steve Vork and Rachel Westberg have drafted an idea for the fundraising graph that would be placed in the newspaper. Discussion regarding what the fundraising goal would be.

• UW-Barron County Scholarship: Steve Vork and Janis Volker met with a representative from the UW-Barron County Scholarship Foundation to discuss a potential CWSF scholarship for CW students attending UW-Barron County. Discussed the various types of scholarships, amounts, and potential conflicts that could arise. It was decided to continue this discussion at a future meeting.

New Business:

- **Portable Toilets for Fishy Four:** Steve reported that we are going ahead with a slight reduction in number to see if it will be sufficient for the use of the racegoers.
- **Fishy Four Donations:** We are on track to receive the same amount for donations for the Fishy Four this year from sponsorships.
